





# The Makers District (Pixel Towers), Al Reem Island, Abudhabi

Pixel Towers is to be set on Reem Island, Abu Dhabi, in Makers District. Seven towers comprise with studios, 1-3-bedrooom apartments, and 4-bedroom Penthouses. The built-up area of the project covers about 83.000 m2. 7 residential towers surround a pedestrianized plaza, home to retail, dining, artisanal food and beverages (F&B) and offices. Architectural appearance of the




